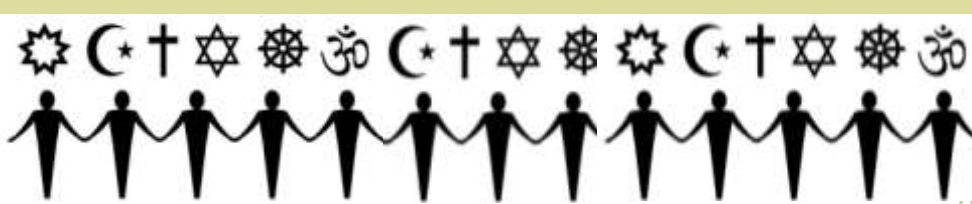

Religious History Association - President's Report for 2013

2103 has seen some changes on the executive as various office-bearers have moved on after a period of considerable service. In the first place your Association now has a new president (myself) following the move by our inaugural president, **Hilary Carey**, to England to take up the post of head of the School of Humanities at Bristol University. The debt of the Association to Hilary is manifold. It was she that largely founded it and who established much of the infrastructure on which it is based including the website, online discussion group and Paypal facility for paying membership dues. We send our best wishes for her new post along with our acknowledgement of all her work in establishing the Association. The position of Secretary has also changed with **Stuart Piggin** being replaced by **Ian Tregenza**, a former committee member. Stuart was a long-standing member of the earlier Association for the *Journal of Religious History* and brought both to it and the current Association his wide knowledge of the field of religious history especially here in Australia. As a mark of his contribution he has been made a Life Member of the Association (see the nomination below). The committee also welcomes another new member, **Glen O'Brien**, who has taken up the hitherto unfilled post of vice-president. Philip Almond and Shurlee Swain continue in their roles as Committee Members.

Another major change in view is the appointment of a new editor/s for the *Journal of the Religious History*. After exemplary service as editors **Carole Cusack** and **Chris Hartney** will reach eight years of service in mid 2015. As with the American presidency eight years is the maximum period for holding that post under the terms of our constitution so it is now time to start looking to give the new incumbent time to acclimatise. A copy of the EOI can be found below: please spread the word or, possibly, consider whether you might be interested. One mark of the flourishing state of the journal is the strong competition for the **Bruce Mansfield Prize** for the best article for the year. This year it was awarded to **Adam Laats** (State University of New York) for his article "Our Schools, Our Country: American Evangelicals, Public Schools, and the Supreme Court Decisions of 1962 and 1963," *Journal of Religious History* (Australia), 36:3 (September 2012): 1-16.

One of the major functions of the Association is to promote the study of religious history in Australia through conferences. To that end the Association has given two \$500 grants as part of its annual program (to support the Evangelical History Conference in Sydney and the Faith and Empire conference in Fremantle). Plans are in place for the traditional biennial joint meeting of the Australian Historical Association conference and the Religious History Association which, in 2014, will be held in Brisbane (July 7-11). The Association will be making possible the visit of a keynote speaker, **Emeritus Professor Ron Numbers**, a distinguished scholar of the history of the relations between science and religion. Our thanks to **Leigh Penman** of the Centre for the History of European Discourses, University of Queensland, for co-ordinating this visit. In 2014 the Society will also be supporting a trans-Tasman initiative, the Marsden bicentennial conference to be held, 26-28 November, 2014, Massey University, Auckland campus with Joanna Cruickshank (*JRH* joint review editor) as the Association representative. The Association's thanks, too, to **Josip Matesic** who coordinated the religious history stream of the July 2013 meeting of the Australian Historical Association conference at Wollongong. Thanks to all who have contributed in their different ways, whether as committee members, regional correspondents or editors over the course of the year with particular acknowledgement of Anna Haunton's work as Assistant Editor of the journal and editor of this newsletter.

The Religious History Association is seeking expressions of interest to edit the journal as the current editors, Carole Cusack and Chris Hartney, will complete their terms in June 2015. The editorship can be held by an individual or jointly. The term would be for two years renewable up to a maximum of four terms (ie eight years).

The journal (founded in 1960) is published by Wiley Blackwell, which handles subscriptions, production and distribution, and all submissions are dealt with through the online platform, Scholar One. Reviews (but not review articles) are handled by a separate Review Editor/s. The journal is also supported by a part-time Editorial Assistant based in the Dept of Studies in Religion, Univ. of Sydney (though the editor/s can be located elsewhere). Funds for this editorial support come from an annual subvention from Wiley who also make provision for some editorial travel relevant to the promotion of the journal. The journal is responsible to the Religious History Association (<http://therha.com.au/>), the President of which is Scientia Professor John Gascoigne, UNSW.

Endorsement of Stuart Piggin's nomination as a life-member of the Religious History Association.

Since the publication of his groundbreaking doctoral thesis, *Making Evangelical Missionaries, 1789-1858* (1984), **Stuart Piggin** has published more than 100 academic articles and seven books, a number of which have become classics in the field. While his most distinguished contribution to international religious history has been focused on the history of Evangelical Christianity Piggin also wrote a critical history of the Mount Kembla Disaster of 1902 (1992). He has also played a critical role in public reception of new research in religious history, including presentations to the first National Forum on Australia's Christian Heritage in Parliament House, Canberra, establishing the School of Christian studies during the period he was Master of Robert Menzies College at Macquarie University from 1990 to 2004. He has also supervised a stream of PhD students, many fostered through his ongoing seminar on Christian history in connection with the Centre for the History of Christian Thought and Experience at Macquarie University.

Stuart Piggin has served with distinction as a member of the Association for the Journal of Religious History since 1990 later serving on the Executive and playing a leading role in the negotiations which led to the formation of Religious History Association through the amalgamation of the Association for the Journal of Religious History and the Religious History Society, including the suggestion for the name of the new organisation. He served as

Treasurer of the Religious History Association from its formation in 2010 until 2013 during a critical period in its establishment.

Stuart Piggin has been at the heart of the academic study of religious history in Australia for more than three decades during which time he has been instrumental in the growth of religious history as a part of the Academy in Australia.

Editors' Report – *The Journal of Religious History*

Without any particular intent from the editors an early thematic arose in the articles of 2013 with both the March edition, and a good part of the June edition of our journal dealing with issues of increasing faithlessness against a background of continued modernity and secularisation. In March, **Clive D. Field** in his "The Faith Society"? Quantifying Religious Belonging in Edwardian Britain 1901-1914" provides a very detailed reading of faith and the loss-of-faith in the homeland of the great empire. The end date of his survey is telling for he presents a scenario of growing irreligiousness in the lead up to the guns of August at a period when, as the war progressed it seems a return to the divine manifest destiny of Britain reinvigorated a religious sentiment that was lost again by 1918. Many of the thematics here look forward to **Ben Edward's** discussion of reactions contra and pro to the 1938 London conference of the World Union of Freethinkers ("The Godless Congress of 1938: Christian Fears About Communism in Great Britain"). A manifestation that led many Christians to wonder about the communist influence the conference would manifest and the hope that such an event would cause a resurgence of faith during very troubling times. Five years earlier, as **Andrew Atherstone** demonstrates the centenary of the Oxford Movement led, initially, to some kind of rapprochement between English Catholics and Protestants before descending into heated sectarian controversy ("Evangelicals and the Oxford Movement"). **Ulrich L. Lehner** ("How Enlightened Can a Monk Be? The Efforts of Eighteenth-Century German Benedictines to Reform Monastery and Church") and **Cadoc Leighton** ("Finding Antichrist: Apocalypticism in Nineteenth Century Catholic England and the Writings of Frederick Faber") are both excellent extended meditations from archival sources. Lehner examines the tensions between an enclosed life and ideals of what religiously it meant to be German as the Enlightenment erupted. Whereas the writings of Frederick Faber, as Leighton shows, highlights ongoing anxieties about the secular and modernity form a very particular English minority position. Finally, **Catherine Byrne** examines the debate from Victoria, through New South Wales to South Australia and Queensland concerning the negotiation of religious instruction and secularism in nineteenth century Australia.

The June issue had less of a thematic unity but was no less fascinating. **Patrick D. Bowen** examined an intriguing dimension of US/Latino culture in his examination of those Latinos who converted to Islam in the early part of the twentieth century. In this article he used history to examine the depths of an emergent Latino/a Muslim identity ("U.S. Latina/o Muslims since 1920: From "Moors" to "Latino Muslims."). A sound examination of inter-Catholic tensions is explored in the article by **Alexander Coello de la Rosa** in his examination of Jesuit activity on the Mariana Islands in such a way as to trace a longer theme in a number of JRH articles on the place of the Jesuits at this time ("Lights and Shadows: The Inquisitorial Process Against the Jesuit Congregation of *Nuestra Señora de la Luz* on the Mariana Islands (1758-1776).") Continuing the Jesuit theme the edition is rounded out with work on Xu Guanqi (an associate of Matteo Ricci) and his acceptance of Christianity by Yu Lui. A new reading through a gender paradigm of Salvation Army conversion narratives in Sweden 1887-1918 by **Johan A. Lundin** and **Nicholas Halter** examines the occasionally belligerent relationship between the Catholic Church and government agencies that lay behind the organization of World Youth Day in Sydney in 2008. In was in this issue that we printed **James Boyd's** "Undercover Acolytes: Honganji, the Japanese Army, and Intelligence-Gathering Operations"

which stands out in my mind because of the solid research done on activities that were ostensibly secret, predominantly the use of Japanese government agents dressed as monks to infiltrate those parts of Asia that Japan was looking to subdue in light of the Meiji Restoration.

Our September issue opened with **Richard Glenn Cole's** reassessment of Martin Luther's rhetorical strategies in relation to "Jews, Princes, Clerics, and Other Enemies." The author here had to walk a fine line between seeming to excuse Luther's perceived bigotries and promote a new understanding of his mode of argument. **Maria L. Ruby Wagner** provides a very considered study of the final years of the life of Bernard of Clairvaux and the role of his engagement with promoting the Second Crusade that demonstrably effected his thinking on a number of issues including his conceptualisation of eschatology. **Stefaan Blancke's** "Catholic Responses to Evolution, 1859-2009" is a very useful overview of this particular topic. The millenarian legacy of Joanna Southcott is presciently examined in **Philip Lockley's** article on the "Israelite Preachers" who grew out of her movement. Finally two very interesting antipodean subjects are introduced. The first by **Richard Cappuccio** in his examination of the early spirituality of the New Zealand author Katherine Mansfield ("The Swinging Gate: Katherine Mansfield's Missionary Vision"). The second, again examining the relationship of education in secular Australia this time with an examination of the founding of the University of Western Sydney in 1989 by **Mark Hutchinson**.

The year ended with a special edition – edited by **Constant Mews** and **Jason Taliadoros** – on law and theology in the medieval period. Mews himself provides an overview of new scholarship in this area. **Clare Monagle** examines both legal and theological developments at the fourth Lateran Council in 1215 and its endorsement of the scholastic theologian **Peter Lombard**. **Atria A. Larson** provides a new reading of Gratian's *Tractatus de penitentia* and how this document takes its place in the ongoing development of both canon law and theology during the twelfth century. For those interested in the Church's attitudes and reactions to the poor at this time, **Jason Taliadoros'** detailed examination of their rights to relief will prove very useful. Again starting with Gratian, **Tomas Zahora** demonstrates how the process of religious law in Western Europe, during the period 1157-1217 is subverted by the study of law in a less traditional sense. He focuses on the career of Alexander Neckam to demonstrate this. The issue of licit violence and how to govern violence by law is an interesting point taken up by **Jasonne M. Grabher** in his examinations of the writings of Giovanni de Legnano's *De Bello*.

Thankfully the journal's page limit allowed the inclusion of two very interesting review essays at the end of the year. The first is an overview of edited editions of the works of Dorothy Day conducted by **Jacob Phillips**. Day was a twentieth century American Catholic activist of some note. The final review essay by **Mike Grimshaw**, examined two recent works that link spirituality, religion and tourism. The books covered are **Alex Norman's** *Spiritual Tourism* and Michael Stausberg's *Religion and Tourism*. This article was appreciated for touching on issues of how one does religious history and made a fine conclusion to a substantial year for the journal.

As one can see from the above summary of the year, there was a tight focus on certain historical periods (the eighteenth and nineteenth centuries), and religious traditions (mainly Christianity) which remain the traditional area of the Journal's scholarly electorate as it were. It was delightful to publish papers that went beyond this electorate, and both Carole and I are proud in particular of the particular scholarship of the special edition and Constant's work on this. As I noted at the start, the issue of history and secularisation continues to develop in these pages and this will not stop soon. **Ian Tregenza** is planning a special edition on secularisation for 2015 and a collection of research from the RHA's conference in Adelaide in 2012 will soon be out through Cambridge Scholars Press. Finally, we cannot thank enough our production assistant Anna Haunton, we thank all our contributors, and particular thanks must always go to our tireless and dedicated army of peer-reviewers. We look forward with relish to another year of editing this incredible journal.

NEW ZEALAND

New Zealand report for the Religious History Association 2012

2014 marks the 200th anniversary of the arrival of Christianity in New Zealand, and work is proceeding in the creation of a reception centre of the place in Rangihoua where the first preaching took place on Christmas Day by Reverend Samuel Marsden.

A book is due out in 2014 with papers on the early mission, Te Rongopai 1814: *Takoto te pai!* *Bicentenary Reflections on Christian Beginnings and Developments in Aotearoa New Zealand*, ed A.K. Davidson et al., and published by the Anglican Church in New Zealand.

Conferences

The conference was held this year in Dunedin. This one day event was a lively and enjoyable day and included a most interesting paper from a keynote speaker at the New Zealand Historical Association conference **Elizabeth Elbourne** from McGill University on Colonialism and Christian humanitarianism in the 1840s, focussing on the Buxton family. Papers were presented by **Malcolm Falloon, Hilary Mitchell, Vivian Caughley, Pamela Welch, Jenny Collins, John Milnes, Kirstine Moffat, Peter Lineham** and **Hugh Morrison**. It was an excellent day.

The Association is sponsoring with TheRHA a conference on Religion in Conflict and Collaboration with the Modern World, to be held in Auckland on 26-28 November 2014, with a keynote address from **Professor Brad Gregory** of Notre Dame. For details see <http://religious-history.massey.ac.nz>.

Stuart Lange, *A Rising Tide: Evangelical Christianity in New Zealand, 1930-65*. Dunedin, New Zealand: Otago University Press, 2013 is a detailed coverage especially of Presbyterians, Anglicans and the Inter-Varsity Fellowship.

Peter Lineham, *Destiny: The Life and Times of a Self-Made Apostle*. Auckland: Penguin, 2013 explores the background and context of A Maori megachurch pastor and colourful politically active leader.

Keith Newman, *Beyond Betrayal: Trouble in the Promised Land, Restoring the Mission to Māori*. Auckland: Penguin, 2013, is the story of the church's impact among Maori after the initial age of missions.

Kevin Ward has two new books, *The Church in Post-Sixties New Zealand: Decline, Growth and Change*. Auckland: Archer Press, 2013, which is case studies of four different Protestant churches in Christchurch.

Current Projects, Awards and Grants

Greg Bailey (La Trobe University) is studying the Composition of the *Mahābhārata* as a response to the Material Success of Buddhism, as well as the Sanskrit words *pravṛtti* and *nivṛtti*. He is also working on an edition and translation of the Sanskrit *Vināyakamāhātmya*

Megan Cassidy-Welch (Monash University), is working on a number of projects including 'War and memory in European culture: a long perspective' (ARC Future Fellowship); 'Battlefields of Memory: Places of War and Remembrance in medieval and early modern England and Scotland' (ARC Discovery Project with Dr D MacKinnon, UQ); and 'Atrocity, Emotion and the thirteenth-century Crusades' (ARC Centre of Excellence for the History of Emotions, Associate Investigator, 2014-17)

Louise Hitchcock (University of Melbourne) is moving into the final year of the ARC Discovery-funded project 'In the Wake of the Sea Peoples, in the Footsteps of Goliath: Excavating the Philistine Site of Tell es-Safi/Gath'.

Peter Howard (Monash University) continues to develop the Centre for Medieval and Renaissance Studies at Monash University which was launched in March 2012. CMRS provides a focused space for graduate training and acts as the body to oversee the Prato Consortium for Medieval and Renaissance Studies and the Bill Kent Library at Monash's Prato campus in Italy. Peter continued his research for the ARC Discovery Project (2011-2013) 'Cultures of Belief in Renaissance Florence'.

Charles Zika (University of Melbourne) is researching 'Emotions and Sacred Space, Europe 1350-1750' for the ARC Centre of Excellence in the History of the Emotions, a project that is funded from 2011-2017. His 4 year Discovery Project "Reading the signs: disaster, apocalypse and demonology in European print culture, 1450-1700" concluded in 2013.

Constant Mews (Monash University) with Peter Howard, Anne Scott, Janice Pinder, Claire Renking and Paul Murray have completed the final year of the ARC Linkage Grant 'Imagining Poverty: conceptualising and representing poverty and the poor in mendicant inspired literature, preaching and visual art 1220 1520. This project explores understandings and representation of poverty, both voluntary and involuntary, in literature and art in Europe 1220 1520 that were inspired by mendicant (particularly Franciscan and Dominican) ideals.

News

The last few years have seen major changes in the structure of theological education in South Australia and in the institutions that teach church history. At the end of 2010 St Barnabas' Theological College (Anglican) withdrew from the Adelaide College of Divinity to affiliate with the School of Theology at Charles Sturt University through an agreement with St Mark's National Theological Centre in Canberra. At the same time, the Catholic Theological College ended its association with the Adelaide College of Divinity though continued, in cooperation with the Uniting Church theological college, to teach for degrees in theology awarded by Flinders University. At the end of 2013 the Catholic Theological College closed and has been absorbed into the Australian Catholic University.

The ACU will take up responsibility for providing theological education in the Catholic tradition within South Australia.

Among the teaching staff to transfer to the ACU is Dr Josephine Laffin, senior lecturer in church history. The Uniting College for Leadership and Theology, located at the ACD campus at Brooklyn Park, will continue to offer degrees in theology awarded by the Adelaide College of Divinity and Flinders University. The Adelaide Theological Library will be reconstituted as an independent body, supported by the Uniting and Catholic churches.

Some recent major publications on Australian religious history

Michael Gladwin, *Captains of the Soul: a history of Australian army chaplains*, Wavell Heights Q: Big Sky Publishing, 2014.

This is a comprehensive account of Australian army chaplains from the Great War of 1914-18 to the recent conflict in Afghanistan. It describes the evolution of the Royal Australian Army Chaplains' Department and assesses the significance of Army chaplaincy for Australia's military, religious and cultural history.

Jonathan Holland, *Anglicans, Trams and Paw Paws: the story of the diocese of Brisbane, 1945-1980*, Brisbane: Copyright Publishing, 2013.

This is a history of the Anglican diocese of Brisbane during the episcopates of three archbishops: Reginald Halse, Philip Strong and Felix Arnott. It describes and analyses the vigorous religious culture of the post-war years, when Anglo-Catholicism was dominant, and the numerical decline and changing shape of the church from the mid-1960s. It includes vivid pen-portraits of the archbishops, leading clergy and prominent lay people and is the first Australian diocesan history to mention the existence of gay clergy.

Hugh Jackson, *Australians and the Christian God: an historical study*, Preston VIC: Mosaic Press, 2013.

This explores the changing shape of religious belief and practice in Australia since 1788 and the extent to which Australians have accepted, or not accepted, the traditional Christian picture of God as both judge and saviour. Jackson concludes that at no time 'did the collective consciousness of Australians become deeply imbued with belief in the truth of the Christian religion'. Based upon a close study of a wide range of sources, this book is a major addition to the scholarly literature on the history of Christianity in Australia.

Research Activity

Ġanūb Qaṣr al-ʿAġūz (Baḥriyya Oasis, Egypt); since 2009. This excavation is part of the research programme "Le christianisme des déserts égyptiens" which **Victor Ghica** has been directing at the Institut Français d'Archéologie Orientale in Cairo since 2005. The fieldwork is supported by both the Faculty of Arts of Macquarie and the Institut Français d'Archéologie Orientale. The dig continued in February 2013 the excavation of the 5th century laura of Ġanūb Qaṣr al-ʿAġūz. Among the significant finds of this season: a 5th century church featuring a totally original plan; massive living quarters have been excavated as well as storage rooms for cereals and wine.

Bribir (Croatia), also to be directed by **Victor Ghica**. The first excavation season is scheduled for April 2014. The dig is supported by the Faculty of Arts of Macquarie University, the Croatian Studies Foundation (Sydney) and the Museum of Croatian Archaeological Monuments (Split).

STUDIES IN RELIGION, UNIVERSITY OF SYDNEY

Introduction

2013 was a busy and productive year for Studies in Religion at the University of Sydney. First Year units RLST 1002 A History of God, Deities and Demons and RLST 1005 Atheism, Fundamentalism and New Religions were solid, Senior units received positive student evaluations, and three students completed Honours. The postgraduate research program continued smoothly with five students submitting doctoral theses, and several new students enrolling in both Semesters 1 and 2.

The department welcomed Dr Alex Norman, already an Honorary Associate in Religion, to the teaching staff. Dr Norman has a .4 teaching contract, extending to 30 June 2014, while Professor Carole M. Cusack is Pro-Dean (Teaching and Learning) in the Faculty of Arts and Social Sciences. Alex Norman is also Managing Editor of the *Journal of Sociology*.

In 2013 Dr Christopher Hartney organized four one-day symposia. These were:

1. Where have all the Cults Gone? A Symposium in Honour of Professor J. Gordon Melton in Conjunction with the Center for the Study of New Religions (CESNUR, Turin) (9 May)

This symposium examines the history of the academic study of 'cults', which emerged in the 1960s and took on two distinct (and oppositional) identities. The first located such new religious phenomena in the discourse of moral panic, and played to the anxieties of community groups such as the Cult Awareness Network (CAN). The second identified not 'cults' but 'new religious movements' and attempted to locate such developments in the overall history of religions. Fifty years later, the moral panic has abated (or rather, it has shifted to Islam, and 'old' religion) and the study of NRMs is a major element in the academic discipline.

2. Religious Identity in the 21st Century: From Indigenous Faiths to Atheist Enthusiasms (18 October)

What are the key motifs to the Study of Religion this century and what is the use of them? For this symposium scholars will examine new trends in the areas of indigenous religion and identity, Fundamentalism, and New Atheism as part of a wider project to critique failing, useful, and potential schemata for the better understanding of religion in this 'new age'. Scholarship will dovetail in diverse and substantive methodological ways with research presently being carried out by Professor James L. Cox (University of Edinburgh) and A/Prof. Adam Possamai (University of Western Sydney) in their investigations of atheist indigeneity in Australia.

3. Brief Encounter: A Symposium on Teaching and Learning for Humanities in the Intensive Mode/Summer School (15 November)

Chris Hartney, together with Alex Norman, Zoe Alderton (Writing Hub) and Elisha McIntyre (PhD candidate, Studies in Religion) organised a teaching colloquium on 15 November 2013 focusing on pedagogical tactics for intensive learning. The colloquium was titled "Brief Encounter: A Symposium on Teaching and Learning Tactics for Humanities in the Intensive Mode (Summer School)" and was opened by Jillian Stewart, the Director of the University of Sydney Summer School. It was well attended by Summer School lecturers and tutors from numerous faculties.

4. The Aesthetics of Trauma, Horror, Atrocity, and the Apocalyptic (29 November)

Western culture is riven with powerful manifestations of violence - both actual and fictive. What is the relationship between the two? On one hand, the most violent episodes of our times seem to be replicated in our cultural artifacts. On the other, the aggression we see in the Hollywood action film amplifies violence to the point that it seems unreal and cartoonish.

Do such cultural artifacts desensitize us to violence, or do they instead relieve or absorb the traumatic experiences of our times? Does the rise of the apocalyptic war film and our fascination with the vitrine of human brutality paraded in the forensic investigation, horror, or blockbuster suspense films explain our inertia in the face continuing global conflict, including the ongoing eruption of genocide around the world from Rwanda to Bosnia?

This report also lists conference papers and academic publications by staff, students and associates, other staff distinctions, PhD graduations and thesis topics, Honours graduations and thesis topics, conferences that the department was involved in, recipients of prizes, and research seminars presented in Studies in Religion in 2013. Centre for Early Christian Studies (CECS)

CECS Conference and Asia-Pacific Early Christian Studies Society (APECSS) meeting

The first Early Christian Centuries conference was held in Melbourne from 3-5 October 2013 at St Patrick's campus, ACU, on the theme: *Men and Women in Early Christianity*. There were three keynote speakers: Professor Elaine Wainwright (University of Auckland), Professor Claudia Rapp (University of Vienna), and Professor Matthijs Lamberigts (Katholieke Universiteit Leuven). Forty-five short papers were also presented. The proceedings, edited by Wendy Mayer and Ian Elmer, will be published in the Early Christian Studies series by St Paul's Press. This conference, which was also the eighth conference of the Asia-Pacific Early Christian Studies Society (APECSS), included the annual planning meeting of CECS (usually attended by Japanese colleagues) and a celebration of the tenth anniversary of the founding of APECSS by Emeritus Professor Shinro Kato (Tokyo) and Professor Pauline Allen of CECS in 2003. Both the conference and meeting were fruitful cross-cultural events.

International visitors

Professor Paul Blowers, Dean E. Walker Professor of Church History at Emmanuel Christian Seminary, Johnson City, Tennessee, was the recipient of one of ACU's Distinguished Honorary Visiting Fellowships in 2013. Professor Blowers delivered a seminar on "The Transfiguration of Jesus Christ as 'Saturated Phenomenon' in Maximus the Confessor", in Brisbane on 31 July. Professor Blowers is also a collaborator on the project *The Oxford Handbook to Maximus the Confessor* which is being edited by **Pauline Allen and Bronwen Neil**.

Dr Nathalie Rambault, a collaborator of the prestigious French series *Sources Chrétiennes* (Lyons) and a specialist in editing texts of John Chrysostom, spent two weeks in Brisbane working with **Pauline Allen** on an edition with a French introduction and translations of five martyr homilies of Chrysostom. This volume has been commissioned by *Sources Chrétiennes*.

Publications

The second volume of thematic studies from CECS, the first of which was published in 2012, was published in August 2013. Edited by **Honorary Fellow Dr Wendy Mayer and Assistant Director Dr Bronwen Neil**, its title is *Religious Conflict from Early Christianity to the Rise of Islam* (Berlin: De Gruyter) and it is comprised of eleven chapters by CECS members and honoraries. Publications of individual members can be found on the new website of CECS, at www.cecs.acu.edu.au.

Collaborations

The development of CECS's ties with Macquarie University and Monash University is very encouraging. At the annual conference of the Australasian Society for Classical Studies in Sydney in January 2013 **Dr Bronwen Neil** convened the third session of the "Epistolary

Conversations” network, comprising four papers from Macquarie staff and students and three from CECS members. A joint volume comprising these and other papers delivered at network meetings, *entitled Collecting Early Christian Letters: From the Apostle Paul to Late Antiquity*, is under consideration by Cambridge University Press. This volume will have seven (out of

thirteen) chapters by members of CECS, including Honorary members, and two chapters from contributors at Macquarie University. At the annual conference of the Society for the Study of Early Christianity at Macquarie University on 4 May, CECS member **Professor James McLaren** delivered the keynote address on the theme “Church and Synagogue”.

Stronger links were forged by CECS with St Andrew’s Greek Orthodox Theological College through **Pauline Allen’s** presentation of a keynote at their annual patristic symposium, this year on St Cyril of Alexandria (September 2013, see <http://www.sagotc.edu.au/364/>), and through **Bronwen Neil’s** presentation of a keynote at the Roundtable on Maximus the Confessor, along with **Paul Blowers and Adam Cooper** from the JP II Institute for Marriage and Family

Pauline Allen and Bronwen Neil presented invited papers at the conference on Preaching After Easter, on 25-26 March, at Katholieke Universiteit Leuven. The proceedings are forthcoming with Peeters.

Fellowships

Dr Geoffrey Dunn held a 10-week research fellowship at St Louis, US, in March-April 2013.

Dr Wendy Mayer will take up a three-month fellowship at Pretoria University, South Africa, in February-May 2014.

New Research Institute

ACU is founding a new research institute in the Faculty of Theology and Philosophy, the Newman Institute for Religion and Critical Enquiry. This will further interdisciplinary collaboration across the Faculty and beyond and promote the development of the basic discipline of Religious History.

CECS has two new international doctoral students, **Kosta Simic** who is working on eighth-century hymnography attributed to Germanos of Constantinople, and **Justin Pigott**, whose thesis is on Early Constantinople: Looking beyond Institutional Continuity in Council Acts. Golding Centre (GC) for Women's History, Theology and Spirituality

To share and promote research in religious history, especially in connection with women, the GC at its Annual Colloquia in 2013 presented the following colloquium:

First Colloquium

Dr Christine Cameron (University of New England Graduate) shared the fruits of her recently published 2009 doctoral thesis "Women Doctors of the Catholic Church: A Study in Servant Leadership". Christine's research focused on the lives and works of St Teresa of Avila, St Catherine of Siena and St Therese of Lisieux in relation to their leadership practices through the lens of the servant leadership paradigm.

Second Colloquium

Dr Ann Maree Whenman (Australian Catholic University Graduate) shared the insights of her doctoral thesis successfully presented in 2012, which focused on the provision of religious education to Catholic children, who did not attend Catholic schools in New South Wales from 1880 to 2000. This is in essence the history of the Confraternity of Christian Doctrine (CCD) within the relevant social, cultural, political, educational and ecclesial contexts and is essentially a history in which women are the key players.

Third Colloquium

Dr Heather O'Connor (Australian Catholic University Graduate 2011) came to her doctoral studies with years of experience in the public education sector and political involvement in the women's movement. With this background she focused on women religious in the Ballarat area concentrating mainly on the Loreto and Mercy Sisters in the period 1950-1980 addressing such questions as: "In what ways were their lives affected by second-wave feminism or, indeed, did they help shape feminism themselves and/or through the young women they taught? In what way, if at all, were the experiences of these women similar to those experienced by women in the second-wave feminist movement beginning in the 1960's."

Currently doctoral students are working on the following topics:

- The history of the Sisters of Mercy in Papua New Guinea;
- The history of TAMAR (Towards A More Appropriate Response), a group of women in the Sydney Anglican Church who worked with the hierarchy to establish protocols and educational material in relation to sexual abuse in the Anglican Church in Australia.
- A history of Catholic Church Insurance in Australia with the accent on the role of the laity.
- The formation of a model for interfaith dialogue between Christian and Muslim women.
